Raffle and drawing will be under the authority of owner Daniel Piacquadio, who will confirm entries and oversee monitoring of the tickets during the raffle period.

(2) The dates and times that the promotion is being conducted.

Friday, September 1st, 2023, beginning at 12:00 AM PST running through Sunday, November 19th, 2023 at 5:00 PM PST. The winner will be drawn at random following the conclusion of the Pittsburgh Steelers and Cleveland Browns football game currently set to start at 11:00 AM MST on November 19th, 2023. The winner will be notified via email and will have 48 hours to respond to the email to claim their prize.

The drawing will be conducted by accumulating the entries in their entirety. Each entry will be assigned a raffle ticket with their name, phone number, and email on it. A random ticket will then be drawn by our partner, Merrill Hoge, during the Unibet event at Harold's Cave Creek Corral on Sunday, November 19th. That ticket will be matched with the corresponding entry ticket. Once we locate the entry, information will be verified to ensure the customer is permitted to win the contest, at which time he or she will be contacted via email. Entry into this contest provides consent to allow Unibet to contact you via email. No entry shall be cancelled. The last four numbers of the raffle ticket will be marked on the bet slip. In the event a wager is cancelled prior to settlement, the raffle ticket will not be eligible to win the grand prize.

(3) The persons who are eligible to participate in the promotion.

To be eligible for this promotion, the player must be 21 years or older. You must have placed a bet worth \$20 USD or higher to qualify. Only wagers placed on NFL will qualify to win the Grand Prize. You must provide your name, email address, and phone number on the back of your ticket to qualify to win the Grand Prize.

(4) The required action to receive whatever is being offered as part of the promotion.

Players can gain one entry to this promotion by placing a \$20 minimum wager on any NFL option. Only one entry per bet slip is permitted.

Example: Player A bets \$20 on any NFL wager. Player A gains 1 additional entry.

Only retail bet slips are eligible for entry into this promotion.

(5) The procedure to claim or redeem the promotional offer, if applicable.

The winner will be notified via email and will have 48 hours to respond to the email to claim their prize.

(6) Registration procedures.

All participants must provide your name, email address, and phone number on the back of their raffle ticket to qualify to win the Grand Prize.

(7) Limitations on participation.

Only players with bet slips from the Unibet Sportsbook kiosks will qualify.

(8) Wagering requirements and limitations by type of game.

Only NFL wagers qualify to win the Grand Prize.

(9) The order in which funds are used for wagering.

Funds are not required to enter the sweepstakes.

Wagers for additional entries must be placed using funds from the cash balance.

(10) Eligible games.

If wagering to earn another entry, players may wager on any NFL sports market wager (ex. Futures, player props, game lines, etc.).

Only retail bet slips are eligible for entry into this promotion.

(11) Any restrictions on the withdrawal of funds.
